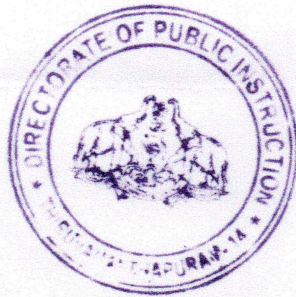

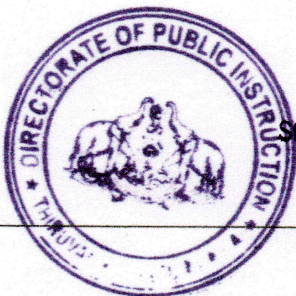


FORMAL PRIOR RECOGNITION LETTER
